
UTILITY LOCATES

All utilities must be identified through the locate process prior to excavation of soil, including boring, can take place. In the event, that a City Utility cannot be located within the specified boundaries of the request area, the contractor/excavator will be notified by e-mail and/or phone of a **mandatory** on-site meeting to discuss alternate measures for protecting the utility. **No** excavation of soil, including boring, is permitted until the on-site meet has taken place and all utilities have been located. Failure to comply will be deemed unreasonable action by the contractor/excavator and may result in the contractor/excavator assuming all liability for damages to such utilities

Red	Electric power lines, cables, conduit, and lighting cables	Blue	Drinking water
Orange	Telecommunication, alarm or signal lines, cables, or conduit	Purple	Reclaimed water, irrigation, and slurry lines
Yellow	Natural gas, oil, steam, petroleum, or other gaseous, or flammable material	Pink	Temporary survey markings, unknown/unidentified facilities
Green	Sewers and drain lines	White	Proposed excavation limits or route

Applicant hereby agrees to comply with all the provisions of the City of Arvada Building Code. Standard Specifications and drawings for design and construction, approved plans or any other Ordinance, Law, Rule or Regulation including EROSION CONTROL, and that this permit shall be invalid if, during the performance of the work, a violation of any of the above ensued. Should violation occur and correction directives are not followed, this permit shall be deemed to be canceled and the improvements shall be made to conform with these provisions or they shall be removed.

Per sections 69.0 and 78-309 of the Arvada Municipal Code, the permittee shall be responsible for and bear the sole cost of any required relocation of their facilities located in or adjacent to public rights-of-way whether above or below ground. By accepting this permit, the permittee acknowledges this requirement.
